**AGENDA TOPIC:**

The following resolution was offered by Alderwoman Mary Melancon, duly seconded by Alderman Lyle Fogleman, and adopted.

A RESOLUTION AUTHORIZING THE MAYOR TO EXECUTE SUPPLEMENTAL AGREEMENT NO. 2 TO THE CITY/STATE AGREEMENT FOR THE DESIGN, CONSTRUCTION, AND MAINTENANCE OF THE I-10 ACCESS ROAD, a.k.a. STATE PROJECT NO H.003758 (FORMERLY 700-01-0114) / FEDERAL AID PROJECT NO. H003758 (FORMERLY DE-0106(500)).

WHEREAS, The City of Crowley (City) entered into an Agreement dated May 31, 2006 with the State of Louisiana Department of Transportation and Development (DOTD) under the above referenced project numbers, subsequently amended under Supplemental Agreement No. 1 dated January 15<sup>th</sup>, 2010; and

WHEREAS, the terms and conditions set forth in Supplemental Agreement No. 2 apparently do not and are not intended to materially change the terms and conditions of the original City/State Agreement as amended by Supplemental Agreement No. 1, but DOTD has requested various amendments and clarifications, generally described as follows:

- Article I (Project Description) provides for an updated State Project Number
- Article II (Funding) provides a more precise breakdown of funding responsibilities
- Article X (Cost Reimbursement) deletes the first paragraph in Supplemental Agreement No. 1 now covered in the amended Article II (Funding)

- Article XII (Final Inspection and Maintenance) provides the same basic language in the original Agreement and Supplemental Agreement No. 1, with sentences re-ordered from Supplemental Agreement No. 1; and

NOW, THEREFORE BE IT RESOLVED by the City of Crowley Board of Alderman in special session duly convened that the Mayor be, and he is hereby authorized, empowered, and directed to execute the aforementioned Supplemental Agreement No. 2;
