RESOLUTION NO. 2015-1

A RESOLUTION OF THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF CROWLEY, ACADIA PARISH, LOUISIANA, REQUESTING THAT THE LOUISIANA DEPARTMENT OF TRANSPORTATION AND DEVELOPMENT (LDOTD) AWARD A CONSTRUCTION CONTRACT FOR THE PROJECT KNOWN AS THE "I-10 SERVICE ROAD EXTENSION" BEARING STATE PROJECT NO. H.003758

WHEREAS, the Louisiana Department of Transportation and Development (LDOTD) advertised for and received sealed bids for the project known as the "I-10 Service Road Extension" bearing State Project No. H.003758 on the 11th day of February, 2015; and

WHEREAS, three bids were received, all within the estimated cost of the project and the amount budgeted for the project; and

WHEREAS, the bids have been reviewed by DOTD and City engineers and said engineers believe it is in order to proceed to award a contract to the lowest responsible and responsive bidder ; and

WHEREAS, the apparent low bid is that of W.E. McDonald & Son, LLC in the amount of \$3,499,158.20;

NOW THEREFORE BE IT RESOLVED by the Board of Aldermen of the City of Crowley, Acadia Parish, Louisiana, in special session duly convened that they do hereby request that LDOTD award a construction contract to the low bidder for the "I-10 Service Road Extension Project" bearing State Project No. H.003758;

BE IT FURTHER RESOLVED that a certified copy of this Resolution be furnished to LDOTD to serve as occasion may require.
