CITY OF CROWLEY REGULAR MEETING JANUARY 12TH, 2016

The Mayor and Board of Aldermen of the City of Crowley, Louisiana, the governing authority of the City of Crowley, met in a regular session at 6:00 p.m. Tuesday the 12th day of January, 2016 at the regular meeting place of said Mayor and Board of Aldermen, the Council Chambers, 426 North Avenue F, Crowley, Louisiana.

Mayor Greg A. Jones presided with the following Aldermen present: Bryan Borill, Elliot Doré, Jeff Doré, Lyle Fogleman Jr., Vernon Martin, Tim Monceaux, Steven Premeaux, Ezora J. Proctor, and Kitty Valdetero.

Alderman Lyle Fogleman led the Pledge of Allegiance to the flag. Alderman Tim Monceaux gave the invocation.

PUBLIC HEARING:

Mayor Greg A. Jones opened the public hearing on Rule to Show Cause for Condemnation of property situated on Lot 6 of Block 112 of the City of Crowley bearing a municipal address of 626 Western Avenue, Crowley, Louisiana belonging to Edmonia Moore. Ms. Rachel Moore was present to represent the property owner's interest in the property. The public hearing was closed.

Mayor Greg A. Jones opened the public hearing on Rule to Show Cause for Condemnation of property situated on Rule to Show Cause for Condemnation of property situated as Lot 7, Block 81, West Crowley having a municipal address of 417 West Hutchinson Avenue owned by Kelly J. Bourque. There was no one present for the property owners. Danny Hebert, City Inspector recommended that the property be condemned. Mayor Greg A. Jones called the public hearing to a close.

COUNCIL MEETING:

A motion was offered by Alderman Elliot Doré and seconded by Alderman Lyle Fogleman to change the February council meeting from February 9th, 2016 to February 10th, 2016 due to the Mardi Gras holidays. Motion carried.

READING & APPROVAL OF MINUTES / BILLS:

Alderman Vernon Martin moved to dispense with the reading of the minutes of the December 8th, 2015 regular council meeting and approve them as written and distributed. Seconded by Alderman Elliot Doré and duly adopted.

Alderman Elliot Doré moved to approve all bills presented for payment. Seconded by Alderman Vernon Martin and duly adopted.

MAYOR'S REPORT:

Mayor Jones presented the Sales Tax chart and User Fee chart that track the collection trend.

STANDING COMMITTEE REPORTS:

UTILITY COMMITTEE:

Chairperson – Alderman Vernon Martin Vice-Chairperson – Alderwoman Kitty Valdetero Members – Aldermen Elliot Doré, Jeff Doré, and Lyle Fogleman, Jr.

A motion was offered by Alderman Vernon Martin and seconded by Alderman Jeff Doré to approve Change Order No. 5 to the contract with Guinn Construction, LLC for "Repairs to the Facultative Pond Levee and Ultra-Violet Disinfection Systems at the Waste Water Treatment Facility" in the amount of \$228,512.86 with an additional 60 days for completion. Motion carried.

PUBLIC SAFETY COMMITTEE:

Chairperson – Alderman Lyle Fogleman, Jr.
Vice-Chairperson – Alderman Bryan Borill
Members – Aldermen Vernon Martin, Tim Monceaux and Steven Premeaux

A motion was offered by Alderman Lyle Fogleman and seconded by Alderman Vernon Martin to approve an increase of \$500 a month for the Police Department. An amendment to this motion was offered by Alderman Elliot Doré and seconded by Alderman Bryan Borill to decrease the initial \$500 a month raise to \$400.00 a month for the Police Department.

Mayor Jones called for discussion. After some discussion, Mayor Jones recognized Chief Gibson who stated that in order for the raises for patrolmen to have the intended effect; he believed the raise should be effective only after officers have served a minimum period after hiring and suggested at least 90 days as a provisional period before any raise would be given. Alderman Vernon Martin offered an amendment to the motion that newly hired police officers receive the salary increase after they have satisfactorily completed a 90 day provisional period, the motion was seconded by Alderman Elliot Doré. The Mayor recognized the motion as an amendment to the main motion and called for further discussion. After brief discussion, the Mayor called the question and the motion to amend carried.

Mayor Jones then opened the floor to discussion on the motion to amend the original motion to decrease the initial \$500 per month raise to \$400 per month. Alderman Borill then asked to withdraw his second to the amended motion which Mayor Jones recognized. Mayor Jones then asked whether any member wished to second Alderman Doré's motion. Hearing none, the motion to amend died for lack of a second.

Mayor Jones then opened the floor for discussion on the main motion as amended to approve a salary increase of \$500 per month for probationary police officers to be effective after they have satisfactorily completed a 90 day provisional period. After a brief discussion, the question was called and the motion as amended carried with one nay vote.

A motion was offered by Ezora Proctor and seconded by Steven Premeaux that the Police Department salary increase be effective April 1st, 2016. Motion carried.
