CITY OF CROWLEY REGULAR COUNCIL MEETING OCTOBER 14, 2008

The Mayor and Board of Aldermen of the City of Crowley, Louisiana, the governing authority of the City of Crowley, met in a regular session at 6:00 p.m. Tuesday the 14th day of October, 2008 at the regular meeting place of said Mayor and Board of Aldermen, the Council Chambers, 426 North Avenue F, Crowley, Louisiana.

Mayor Greg A. Jones presided with the following Aldermen present: Elliot Doré, Jeff Doré, Vernon Martin, Mary Melancon, Laurita Pete, Steven Premeaux, Kitty Valdetero and Todd Whiting. Alderman Lyle Fogleman Jr., was absent.

Alderman Todd Whiting led the Pledge of Allegiance to the flag and Alderman Vernon Martin gave the invocation.

APPEARANCES:

Mr. Gill Pinac came before the assembly to make it known that his intentions are to serve as Public Service Commission of District 4. The election will be held on April 4, 2009.

PUBLIC HEARINGS:

Mayor Jones opened the public hearing on Rule to Show Cause for Condemnation of Property on Lot 14 of Block 5 Walker Addition, having a municipal address 926 West 3rd Street, Crowley, Louisiana belonging to Earl Grant, Jr. Mr. Glen Howie, the attorney appointed to represent the interest of the heirs to the property, was present. WHEREAS, the City of Crowley thereafter retained the services of a structural engineer to inspect the bridge, present options regarding the repair or replacement of the bridge, and to also prepare opinions of probable cost for each respective option which range from \$300,000 to \$700,000; and

WHEREAS, the cost to complete even the minimum required repairs in order to reopen the bridge will cause undue stress on the current funds of the City of Crowley; and

WHEREAS, it is in the best interests of both the Acadia Parish Police Jury and the City of Crowley to maintain a bridge at this location in order to continue the flow of vehicular traffic from the north side of Bayou Blanc to the south side and vice versa between areas both inside and outside the City of Crowley.

NOW, THEREFORE, BE IT RESOLVED by the Board of Aldermen of the City of Crowley in regular session duly convened, that the City of Crowley hereby requests financial assistance from the Acadia Parish Police Jury to repair or replace the Avenue H Bridge crossing Bayou Blanc in the City of Crowley and/or include this project in the Federal Off-System Bridge Replacement Program at the earliest possible date.

WHEREAS, in order to better serve the needs of the community and to become ADA compliant, substantial renovations to the restroom facilities are necessary; and

WHEREAS, the estimated cost of the renovations will be approximately \$60,000.00 of which \$50,000.00 is sought as a grant for assistance and the City will provide matching funds in the amount of \$10,000.00;

NOW THEREFORE BE IT RESOLVED by the Mayor and Board of Aldermen of the City of Crowley, Acadia Parish, Louisiana, in regular session duly convened, that they do hereby authorize, empower and direct the Honorable Greg A. Jones, Mayor of the City of Crowley, to execute and submit an application for a grant to assist in the renovation of the restroom facilities in the Martin Luther King Community Center to the Louisiana Office of Community Development, Local Government Assistance Program in the amount of \$50,000.00; and

BE IT FURTHER RESOLVED that they do hereby authorize the commitment to provide local matching funds of \$10,000.00 to fund the estimated construction cost of \$60,000.00 and said local match shall be included in the grant application; and

BE IT FURTHER RESOLVED that the said Honorable Greg A. Jones, Mayor, is hereby authorized, empowered and directed to execute any and all documents and to provide any and all information as may be meet and proper in the premises.
