The following resolution was offered by Alderman Vernon Martin, duly seconded by Alderwoman Ezora Proctor, and adopted.

A RESOLUTION OF THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF CROWLEY, ACADIA PARISH, LOUISIANA, ACCEPTING THE LOW BID OF PREMIER FIRE EQUIPMENT, L.L.C., FOR THE PURCHASE OF THIRTY-SIX (36) SELF CONTAINED BREATHING APPARATUS WITH ACCESSORIES, AWARDING AND AUTHORIZING THE EXECUTION OF A CONTRACT IN THE AMOUNT OF TWO HUNDRED FIVE THOUSAND TWO HUNDRED & NO/100 (\$205,200.00) DOLLARS AND THE EXECUTION OF ALL DOCUMENTS ASSOCIATED THEREWITH AND NECESSARY THERETO; AND TO PROVIDE FOR ALL MATTERS RELATIVE THERETO.

WHEREAS, the City of Crowley advertised for sealed bids for the purchase of thirty (36) Self Contained Breathing Apparatus (SCBA) with accessories to be delivered to the office of the Clerk of the City of Crowley by 2:00 p.m., Tuesday, February 10, 2016 and there to be opened, read aloud and disclosed to the public; and

WHEREAS, two sealed bids were received by the City of Crowley in response to the advertisement for thirty-six (36) Self Contained Breathing Apparatus and accessories which bids were opened, read aloud and disclosed to the public on the 10th day of February, 2016 and taken under advisement; and

WHEREAS, the bids properly submitted, opened and read by the City Clerk were reviewed for compliance with the specifications, the bidding process and to determine the low bidder; and

WHEREAS, the bid of Premier Fire Equipment, L.L.C., was reviewed and it was determined that same was in compliance with the specifications and that the bid of Premier Fire Equipment, L.L.C. appears to have submitted the low bid in accordance with the specifications of the Crowley Fire Department; and

WHEREAS, the Honorable Jody Viator, Fire Chief of the City of Crowley, has recommended the acceptance of the bid of Premier Fire Equipment in the amount of Two Hundred Five Thousand Two Hundred & No/100 (\$205,200.00) Dollars for the purchase of thirty-six (36) Self Contained Breathing Apparatus with accessories as specified with warranty; and

WHEREAS, after due consideration, the Mayor and Board of Aldermen have determined Premier Fire Equipment, L.L.C. to be the low bidder, accepted the recommendation of the Fire Chief and deem it appropriate to accept the bid and award the contract.

NOW THEREFORE BE IT RESOLVED by the Board of Aldermen of the City of Crowley, Acadia Parish, Louisiana, in special session duly convened that they do hereby accept the low bid of Premier Fire Equipment, L.L.C., for the purchase of thirty-six (36) Scott Air-Pak X3, NFPA 1981, Compliant, 2013 Edition, Self Contained Breathing Apparatus with accessories including AV-3000 HT face piece, EPIC 3 voice amplifier, pack alert and tracker locator devices, four (4) NFPA 1981 Compliant, 2013 Edition Face Pieces with Voice Amp, seven (7) Buddy Breathers to be added to the packs and one (1) Firefighter Locator with Truck Mount, all with warranty per the specifications and do hereby award a contract for the said purchase to Premier Fire Equipment, L.L.C. in the amount of Two Hundred Five Thousand Two Hundred & No/100 (\$205,200.00) Dollars; and

BE IT FURTHER RESOLVED that they do hereby authorize empower and direct the Honorable Greg A. Jones, Mayor the City of Crowley to execute a contract with Premier Fire Equipment, L.L.C. under the terms and conditions acceptable to the City of Crowley in his sole discretion for the acquisition of (36) Scott Air-Pak X3, NFPA 1981, Compliant, 2013 Edition, Self Contained Breathing Apparatus with accessories including AV-3000 HT face piece, EPIC 3 voice amplifier, pack alert and tracker locator devices, four (4) NFPA 1981 Compliant, 2013 Edition Face Pieces with Voice Amp, seven (7) Buddy Breathers to be added to the packs and one (1) Firefighter Locator with Truck Mount, all with warranty per the specifications for a total contract price of Two Hundred Five Thousand Two Hundred & No/100 (\$205,200.00) Dollars; and

BE IT FURTHER RESOLVED that the said Honorable Greg A. Jones, Mayor, be and he is hereby authorized, empowered and directed to execute and provide any and all other documents and information which may be necessary in contact with the award of the contract and/or comply with the grant conditions in his sole discretion.

THUS DONE AND ADOPTED in special session duly convened on the 22nd day of February, 2016, pursuant to notice thereof duly published and called in accordance with law and notice thereof having been properly posted, in Crowley, Acadia Parish, Louisiana, at which a quorum was present and acting throughout.
