CITY OF CROWLEY REGULAR COUNCIL MEETING FEBRUARY 14, 2006

The Mayor and Board of Aldermen of the City of Crowley, Louisiana, the governing authority of the City of Crowley, met in a regular session at 6:00 p.m. Tuesday the 14th day of February, 2006, at the regular meeting place of said Mayor and Board of Aldermen, the City Hall, 426 North Avenue F, Crowley, Louisiana.

Mayor de la Houssaye presided with the following Aldermen present: Dr. James M. Buatt, Tiger Istre, Woody Marceaux, Vernon Martin, Mary T. Melancon, Steven C. Premeaux, Ira Thomas and Kitty Valdetero Alderwoman Laurita D. Pete was absent.

Alderman Premeaux led the Pledge of Allegiance to the flag and Alderman Marceaux gave the invocation.

AGENDA AMENDMENTS:

Alderwoman Melancon offered a motion to consider the employment of Bart Habetz. Seconded by Alderwoman Valdetero and duly adopted after a unanimous vote.

PRESENTATION:

Mr. Regan administered the Oath of Office to Mr. Jules Menou as a board member of the Crowley Planning Commission.

PUBLIC HEARING:

Mayor de la Houssaye opened the public hearing on proposed ordinance no. 1331, the ordinance to amend and enlarge the corporate boundaries was read by title.

Mr. Regan asked for opponents to the proposed ordinance no. 1331. A third and final call was made with no one coming forward to speak.

The call for proponents of the proposed ordinance no. 1331 was made and there were no comments after the third and final call.

Mayor de la Houssaye called the public hearing to a close.

Mayor de la Houssaye opened the public hearing on proposed ordinance no. 1332, the ordinance to amend the fiscal 2006 budget was read by title.

Mr. Regan asked for opponents to the proposed ordinance no. 1332. A third and final call was made with no one coming forward to speak.

The call for proponents of the proposed ordinance no. 1332 was made and there were no comments after the third and final call.

Mayor de la Houssaye called the public hearing to a close.

READING & APPROVAL OF MINUTES / BILLS:

Alderman Istre moved to dispense with the reading of the minutes of the January 10th, 2006 regular council meeting and approve them as written and distributed. Seconded by Alderman Thomas and duly adopted.

Alderwoman Melancon moved to approve all bills presented for payment. Seconded by Alderman Buatt and duly adopted.

MAYOR'S REPORT:

Mayor de la Houssaye presented the Sales Tax chart and User Fee chart that tract the collection trend since fiscal 1992. The Recap of all Funds Report compares actual revenues and expenditures for the fiscal year 2006 to the budgeted revenues and expenditures of the same period.

STANDING COMMITTEE REPORTS:

PUBLIC WORKS:

Alderwoman Melancon offered a motion to authorize the addition of centerline pavement striping on Pine Street from Avenue C to Hoyt Avenue to the contract with Pavement Striping, Inc. for Pedestrian Striping on Eastern Avenue (6th Street to Northern Avenue). Seconded by Alderman Martin and duly adopted.

UTILITY:

Alderman Martin offered a motion to authorize Mader Engineering, Inc. to proceed with Phase I to convert the existing sewer wye records to computer format and amend the Utility Fund Budget to provide \$17,500 for this purpose. Seconded by Alderwoman Valdetero and duly adopted.

PUBLIC SAFETY:

Alderman Buatt offered a motion to transfer \$3,500 from the Fund Balance of General Fund to the Firemen's Extrication account. Seconded by Alderman Marceaux and duly adopted.

Alderman Buatt offered a motion to authorize a change order to add 42 days for delivery of the aerial fire apparatus due to Change Order No. 1 Seconded by Alderman Marceaux and duly adopted.

Alderman Buatt offered a motion to waive $\frac{1}{2}$ of the assessment penalty (\$1,800) to Bon Aventure for late delivery of the aerial fire apparatus. Seconded by Alderwoman Melancon and duly adopted.

Alderman Buatt offered a motion to authorize the Police Chief to hire 4 dispatchers and to amend the budget to fund the salaries in the amount of \$42,000 effective March 1, 2006 for the remainder of the fiscal year. Seconded by Alderman Premeaux and duly adopted.

A RESOLUTION OF THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF CROWLEY, ACADIA PARISH, LOUISIANA, AUTHORIZING THE CREATION THE POSITION OF POLICE DISPATCHER OF CREATING FIVE POSITIONS OR SLOTS FOR POLICE POLICE DISPATCHER IN THE DEPARTMENT, AUTHORIZING THE HIRING OF FIVE PERSONS TO FILL THE POLICE DISPATCHER SLOTS; FIXING THE STARTING SALARY FOR POLICE DISPATCHER; TO AMEND THE BUDGET TO PROVIDE FUNDING FOR AUTHORIZING POLICE DISPATCHERS AND AN APPROPRIATION OF \$42,000.00 TO THE POLICE DEPARTMENT BUDGET; TO ELIMINATE ONE RECORDS CLERK POSITION AND TO TRANSFER THE REMAINING SALARY AND FUNDS FOR THE RECORDS CLERK POSITION FOR POLICE DISPATCHER; REQUESTING THE LOCAL MUNICIPAL FIRE AND POLICE CIVIL SERVICE BOARD TO IMMEDIATELY TAKE THE APPROPRIATE STEPS TO CREATE THE

CLASSIFIED POSITION OF POLICE DISPATCHER AND TO BEGIN THE PROCESS TO APPROVE THE CLASSIFICATION AND THE DUTIES THEREUNDER AND TO COMPLY WITH ALL CIVIL SERVICE LAW AND REQUIREMENTS AS NECESSARY; TO REQUEST THAT UPON APPROVAL OF THE CLASSIFICATION, THE BOARD RECOGNIZE THOSE PERSONS HIRED TO BECOME CLASSIFIED EMPLOYEES IMMEDIATELY WITHOUT THE NECESSITY OF A COMPETIVE EXAMINATION AND TO IMMEDIATELY BEGIN THEIR WORKING TEST; TO THE MAYOR AND CHIEF OF POLICE TO DO ALL THINGS NECESSARY IN CONNECTION THEREWITH; AND TO PROVIDE FOR ALL MATTERS RELATIVE THERETO.

WHEREAS, the City of Crowley Police Department dispatching operations are currently handled by the Acadia Parish Sheriff's Department under the terms of an Intergovernmental Agreement in exchange for the use of the City Jail to house Department of Correction (DOC) prisoners classified as trustees; and

WHEREAS, the City of Crowley received written notice from the Honorable Wayne Melancon, Acadia Parish Sheriff, by letter dated February 1, 2006, that the Intergovernmental Agreement was being terminated effective March 1, 2006; and

WHEREAS, the removal of the Sheriff's personnel from the facility will result in the loss of dispatching function and will require office personnel to man the Police Department after regular office hours; and

WHEREAS, the Honorable K.P. Gibson, Chief of Police of the City of Crowley, has recommended that the City Police resume dispatching services and man the Police Department by hiring five additional personnel for dispatching purposes; and

WHEREAS, it is necessary to create the position of police dispatcher to perform the task to be assigned by the Chief of Police, to create five additional budget slots, to fix the starting salary of the police dispatching personnel and to amend the budget and appropriate the necessary funds for police dispatching personnel; and

WHEREAS, it is necessary to eliminate a records clerk and transfer the salary to the dispatching budget to accomplish same; and

WHEREAS, it is required the local Municipal Fire & Police Civil Service Board be notified and requested to create a new classification of Police Dispatcher, to begin the process under State Civil Service law and regulations law as may be required;

NOW THEREFORE BE IT RESOLVED by the Mayor and Board of Aldermen of the City of Crowley, Acadia Parish, Louisiana, in regular session duly convened that they do hereby create the position of police dispatcher for the Crowley Police Department which duties shall be assigned by the Chief of Police in accordance with his discretion; that they do hereby authorize five slots for personnel to be added for dispatcher as full-time employees; that the Crowley Municipal Fire & Police Civil Service Board be notified of this action and they are hereby requested by this Board of Aldermen to consider creating the classified position of police dispatcher and to begin the process and to do and perform all things as may be necessary and proper to classify the job duties and responsibilities thereunder as required by State Civil Service law and requirements; and that those persons hired immediately under the authority of this resolution be recognized in the classified position of police dispatcher immediately and without the necessity of a competitive examination therefor and that they immediately begin their working test; and that the current year's budget be amended by adding thereto an appropriation of \$42,000.00; and the starting salary of the police dispatcher shall be fixed at \$1,400.00to provide funds therefor; and BE IT FURTHER RESOLVED that the Mayor and Chief of Police be and they are hereby authorized and directed to do and perform all things as may be necessary and proper to fully carry out the intent and purpose of this resolution.

NOW THEREFORE BE IT RESOLVED by the Mayor and Board of Aldermen of the City of Crowley, Acadia Parish, Louisiana, in regular session duly convened that they do hereby authorize, empower and direct the Honorable Isabella L. de la Houssaye, Mayor of the City of Crowley, to execute an Intergovernmental Agreement with the Crowley Chamber of Commerce, a non-profit organization, to lease office space within the Enterprise Center in exchange for operating and managing the business incubator, providing assistance in the development of new businesses, provide advice and access to business consultants and others to create workable business plans, to manage the physical assets, including office space, secretarial and administrative services, business consultations, soliciting new businesses and enterprises, handling referrals and inquiries, promote and assist in developing additional jobs through new businesses, providing assistance to existing businesses, to provide consultation, advice and support for the development of business opportunities and to promote the development and organization of new or existing businesses in the community.

> AN ORDINANCE AMENDING THE BUDGETS FOR THE CITY OF CROWLEY FOR THE FISCAL YEAR, BEGINNING SEPTEMBER 1, 2005 AND ENDING AUGUST 31, 2006; AND TO PROVIDE FOR ALL MATTERS RELATIVE THERETO; AND TO REPEAL ALL ORDINANCES OR PARTS OF ORDINANCES INCONSISTENT OR IN CONFLICT THEREWITH.

ORDINANCE NO. 1331

AN ORDINANCE AMENDING AND ENLARGING THE CORPORATE BOUNDARIES OF THE CITY OF CROWLEY, ACADIA PARISH, LOUISIANA, DEFINING THE BOUNDARY OF A TRACT OF LAND CONTAINING 1.785 ACRES SITUATED IN NORTHWEST QUARTER OF SECTION 34, TOWNSHIP 9 SOUTH, RANGE 1 EAST, ACADIA PARISH, BEING BOUNDED ON THE NORTH BY THE NORTHERN BOUNDARY LINE OF SECTION 34, ON THE SOUTH AND EAST BY DR. JOHN BURGIN ET AL AND ON THE WEST BY THE EASTERN RIGHT OF WAY OF TOWER ROAD (LOUISIANA STATE HIGHWAY 1111 SPUR), WHICH SHALL BE ZONED "COMMERCIAL 3, C-3"; AND TO PROVIDE THAT THE AREA SHALL BE A PART OF WARD 1 OF THE CITY OF CROWLEY: AND TO REDEFINE AND RESTATE THE BOUNDARY OF THE CORPORATE LIMITS OF THE CITY OF CROWLEY; AND TO PROVIDE FOR ALL MATTERS RELATIVE THERETO; AND TO APPEAL ALL OR ORDINANCES PARTS OF **ORDINANCES** INCONSISTENT OR IN CONFLICT THEREWITH.

WHEREAS, the City of Crowley has received a petition for annexation from John Burgin, the owner of the property situated in Section 34, Township 9 South, Range 1 East, Acadia Parish, Louisiana, which is contiguous to the corporate limits of the City of Crowley; and

WHEREAS, it is the determination of the Mayor and Board of Aldermen that the property is contiguous to the corporate boundaries of the City of Crowley and it is desirable to include this property within the corporate boundaries; and

WHEREAS, a public hearing having been held in accordance with law on the 14th day of February, 2006, at 6:00 o'clock p.m. at City Hall, Crowley, Louisiana; and

WHEREAS, there being no adverse comments to the proposed annexation, zoning or other matters relative thereto;

NOW THEREFORE BE IT ORDAINED by the Board of Aldermen of the City of Crowley, Acadia Parish, Louisiana, in regular session that:

SECTION 1: Under the provisions of Louisiana Revised Statute 33:171 et seq. and the special enabling legislation under La. R.S. 33:172.3, the Mayor and Board of Aldermen of the City of Crowley have determined that the requirements and provisions of law for annexation have been met and that the annexation of the property is necessary to establish an area completely within the corporate limits of the City of Crowley; and a public hearing having been held in accordance with law on the 14th day of February, 2006 on the question of the adoption of the ordinance, the annexation of the area, the zoning requirements, utility services and the zoning of the areas to be annexed having been considered; after due consideration, the requirements of law having been complied with, the hereinafter described area or territory is hereby included within the corporate limits and the boundaries of the City of Crowley, Louisiana, which territory is hereby defined with certainty and precision as shown on the attached:
