PUBLIC HEARINGS:

Mayor Greg A. Jones opened the public hearing on Rule to Show Cause for Condemnation of property situated on Lot 4 of Block 7 of Duson's 4th Addition to the City of Crowley bearing a municipal address of 917 East 6th Street, belonging to the Unopened Succession of Verna Hoffpauir Marx. Mr. Glenn Howie was present to represent the property owner's interest in the property. This hearing was recessed and will continue at the next regular scheduled council meeting on July 9th, 2013.

Mayor Greg A.
