CITY OF CROWLEY REGULAR COUNCIL MEETING JULY 13, 2004

The Mayor and Board of Aldermen of the City of Crowley, Louisiana, the governing authority of the City of Crowley, met in a regular session at 6:00 p.m. Tuesday the 13th day of July, 2004, at the regular meeting place of said Mayor and Board of Aldermen, the City Hall, 426 North Avenue F, Crowley, Louisiana.

Mayor de la Houssaye presided with the following Aldermen present: James M. Buatt, Tiger Istre, Woody Marceaux, Vernon Martin, Mary T. Melancon, Steven C. Premeaux, Ira Thomas and Kitty Valdetero. Alderwoman Laurita D. Pete was absent.

Alderman Thomas led the Pledge of Allegiance to the flag and Alderman Martin gave the invocation.

Representative Gill Pinac came before the assembly to summarize the capital outlay funds that were given to the City of Crowley in the legislative session.

PUBLIC HEARINGS:

Mayor de la Houssaye opened the public hearing on proposed ordinance no. 1290. The ordinance on La State Uniform Construction Code was read by title.

- Mr. Regan asked for opponents to the proposed ordinance no. 1290. A third and final call was made with no one coming forward to speak.
- Mr. Regan asked for proponents of the proposed ordinance no. 1290. There were no comments after the third and final call.

Mayor de la Houssaye called the public hearing on proposed ordinance no. 1290 to a close.

Mayor de la Houssaye opened the public hearing on Proposals for a SLEMCO Franchise and Streetlight Agreement.

- Mr. Ken Bordelon, a representative from SLEMCO, explained new proposals offered by SLEMCO on the Franchise and Streetlight Agreement with the City of Crowley.
- Mr. Regan asked for proponents on the public hearing. Ms. Jennifer Haynes a representative of K.S.I.G., K.Q.I.S. and K.B.E.B., requested a favorable consideration on behalf of SLEMCO. Mr. Bill Young a representative of the First Turn and a council member in Scott, strongly suggested to grant SLEMCO a francise.
- Mr. Regan asked for opponents on the public hearing. Mrs. Sabrina Salling, a representative of CLECO, spoke and distributed a booklet that details the best energy values provided by CLECO. Mrs. Ezora Proctor, a member of Acadia Parish School Board, emphasized that CLECO was considerate in issues concerning the youth.

A written statement was read from Mr. Bill Hoffpauir urging the City Council to vote "for" the SLEMCO franchise.

WHEREAS, the First National Bank of Louisiana has requested that the City reauthorize the issue of the Standby Letter of Credit and the pledge of funds associated therewith; and

WHEREAS, the City of Crowley continues to maintain its own self-insured Workers' Compensation Program and the amount of security has bee reduced to

\$150,000.00, as is evidenced by the Letter of Credit #318 of the First National Bank of Louisiana; and

WHEREAS, the City of Crowley desires to reauthorize the transaction.

NOW THEREFORE, BE IT RESOLVED by the Mayor and Board of Aldermen of the City of Crowley, Parish of Acadia, in regular session duly convened, that they do hereby authorize, empower and direct the Honorable Isabella L. delaHoussaye, Mayor of the City of Crowley, to execute an application for a line of credit in the amount of \$150,000.00 from First National Bank of Louisiana, to approve the form and substance of the irrevocable Standby Letter of Credit, to execute a promissory note in favor of the First National Bank of Louisiana in the amount of \$150,030.00 bearing simple interest at a variable rate per annum equal to three (3) percentage points over the six month CD rate (currently 0.75%) payable on demand, to pledge an unencumbered Certificate of Deposit to the First National Bank of Louisiana as security for the said Standby Letter of Credit and to authorize the assignment of the deposit account as required by the Bank to pay an annual fee not to exceed one (1%) percent of the amount of the Standby Letter of Credit, to pay all costs and fees in connection with this transaction, to provide a governmental certificate of existence and authority, to pledge the irrevocable Standby Letter of Credit by the First National Bank of Louisiana on behalf of the City of Crowley to the Louisiana Office of Workers' Compensation as security for the City's self-insured workers' compensation program; and

BE IT FURTHER RESOLVED by the Mayor and Board of Aldermen of the City of Crowley, Parish of Acadia, that the Honorable Isabella L. delaHoussaye, Mayor of the City of Crowley, be and she is hereby authorized, empowered and directed to execute any and all necessary forms, documents, assurances and provisions as may be meet and proper in the premises necessary to conclude said transaction.

WHEREAS, the application of uniform modern construction codes will eliminate obsolete, conflicting and unnecessary construction regulations which limit the use of new methods and materials which unnecessarily increase the cost of construction and variation in the application of construction standards caused by the modern construction codes; and

WHEREAS, the adoption of uniform state regulations will insure the application of a modern uniform construction code which will lower the cost of construction for the citizens of the state while insuring healthy, safe and sanitary construction of buildings; and

WHEREAS, this Ordinance has been duly introduced by title and notice of this Ordinance and of public hearing having been published; and

WHEREAS, a public hearing having been held in accordance with law on the 8th day of June, 2004 at 6:00 o'clock p.m. at City Hall, Crowley, Louisiana; and

NOW THEREFORE BE IT ORDAINED by the Mayor and Board of Aldermen of the City of Crowley, Acadia Parish, in regular session, duly convened that:

SECTION 1: Section 5-2 of Article I of Chapter 5 of the Code of Ordinances of the City of Crowley be and the same is hereby amended and re-enacted to read as follows:

Sec. 5-2 Adoption of Louisiana State Uniform Construction Code.

There is hereby adopted by the city, for the purpose of establishing rules and regulations for the construction, alteration, removal, demolition, equipment, use and occupancy, location and maintenance of buildings and structures, including permits and penalties, that certain building code known as the Louisiana State Uniform Construction Code, which code consists of the 2000 edition of the International Building Code, published by the International Code Council, which replaces the 1997 Standard Building Code; the 1999 edition of the National Electrical Code published by the National Fire Protection Association; and the 2000 edition of the Louisiana State Plumbing Code, published by Louisiana Department of Health and Hospitals; the 2000 International Mechanical Code and the 2000 International Fuel Gas Code, of which not less than three copies have been and now are filed in the office of the clerk of the city, and the same are hereby adopted and incorporated as fully as if set out at length in this section and the provisions thereof shall be controlling in the construction of all buildings and structures therein contained within the corporate limits of the city. The State Uniform Construction Code shall be effective January 1, 2004.

SECTION 2: Section 5-28 of Article II of Chapter 5 of the Code of Ordinances of the City of Crowley be and the same is hereby amended and re-enacted to read as follows:

Sec. 5-28. National Electric Code – Adopted.

The National Electrical Code, 1999 edition, adopted and sponsored by the National Fire Protection Association, as hereafter amended, is hereby adopted and made a part of this article as fully as if set out at length herein, to govern and control the installation, repair and maintenance of electric wiring and other electrical devices, equipment and installation.

SECTION 3: Section 5-60 of Article III of Chapter 5 of the Code of Ordinances of the City of Crowley be and the same is hereby amended and re-enacted to read as follows:

- Sec. 5-60. International Building Code and International Mechanical Code adopted; penalty.
- (a) *Adopted*. The International Building Code, 2000 edition, published by the International Code Council, which replaces the 1997 standard building code, is hereby adopted and made a part of this article as fully as if set out herein at length, to govern and control the minimum standards of housing for dwelling purposes in the city.
- (b) *Adopted*. The International Mechanical Code, 2000 edition, published by the International Code Council, is hereby adopted and made a part of this article as fully as if set out herein at length, to govern and control the minimum standards of building purposes in the city.
- (c) *Penalty*. Any person who shall be convicted of a violation of any of the provisions of the housing code, of failure to comply therewith, or of a violation or failure to comply with any order made thereunder, or failure to comply with such an order, as affirmed or modified by the appeal body therein provided for, or by a court of competent jurisdiction, or of a violation of any of the provisions of this article shall, for each violation and noncompliance, be punished as provided in Section 1-8 of this Code of Ordinances. The imposition of one penalty for any violation shall not excuse the violation or permit it to continue, and all such persons shall be required to correct or remedy such violations or defects within a reasonable time. When not otherwise specified, each ten (10) days that prohibited conditions are maintained shall constitute a separate offense. The application of any penalties shall not be held to prevent the enforced removal of prohibited conditions.
- SECTION 4: Section 5-100 of Article IV of Chapter 5 of the Code of Ordinances of the City of Crowley be and the same is hereby amended and re-enacted to read as follows:
 - Sec. 5-100. State plumbing code; compliance.
- SECTION 5: Section 5-101 of Article IV of Chapter 5 of the Code of Ordinances of the City of Crowley be and the same is hereby amended and re-enacted to read as follows:
 - Sec. 5-101. Louisiana State Plumbing Code; adopted, penalty.
- (a) Adopted. There is hereby adopted for the purpose of prescribing standards and regulations governing construction, alteration, repair, equipment, use and occupancy, location, maintenance, removal and demolition of every building or structure or any appurtenances connected or attached to such building or structure within the city that certain code known as the Louisiana State Plumbing Code, 2000 edition, published by the Louisiana Department of Health and Hospitals, is hereby adopted and made a part of this article as fully as if set out herein at length and the provisions thereof shall be controlling within the limits of the city.
- (b) *Penalty*. Any person who will violate any of the provisions of he code herby adopted or fail to comply therewith shall severally for each and every such violation and noncompliance respectively be guilty of a misdemeanor and shall be subject to penalties for the violation thereof as provided in Section 1-8. However, the imposition of a penalty for any violation shall not excuse the violation or defects within a reasonable time, and the application of such a penalty shall not be held to prevent the enforced removal of prohibited conditions.
- SECTION 6: Section 5-103 of Article IV of Chapter 5 of the Code of Ordinances of the City of Crowley be and the same is hereby amended and re-enacted to read as follows:
 - Sec. 5-103. International Fuel/Gas Code adopted; penalty.
- (a) There is hereby adopted by the governing body for the purpose of prescribing regulations governing the installation or alteration of gas piping and appliances, demolition and moving of buildings, that certain code printed in pamphlet form known as the International Fuel/Gas Code, 2000 edition, published by the International Code Council, is hereby adopted and incorporated as fully as if set out in length herein, and from the date on

which this section shall take effect, the provisions thereof shall be controlling within the corporate limits of the city.

(b) Any person failing to comply with any provisions of the gas code, or failing to comply with any order of the inspector, shall be deemed guilty of a misdemeanor, and the gas fitter's license of such person may be revoked.

SECTION 7: This Ordinance shall become effective immediately upon its adoption.

SECTION 8: If any provision, part, word, section, subsection, sentence, clause, or phrase of this ordinance should be held invalid by a court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this ordinance and do hereby declare the provisions hereof, to be severable, then in that event, only that particular provision, part, word, section, subsection, sentence, clause or phrase shall be deemed unconstitutional or invalid and the remaining provisions, parts, words, sections, subsections, sentences, clauses or phrases will not be affected and shall continue in full force and effect.

SECTION 9: All ordinances or parts of ordinances inconsistent with or in conflict herewith be and the same are hereby repealed.
