The Mayor and Board of Aldermen of the City of Crowley, Louisiana, the governing authority of the City of Crowley, met in a regular session at 6:00 p.m. Tuesday the 13<sup>th</sup> day of July, 2010 at the regular meeting place of said Mayor and Board of Aldermen, the Council Chambers, 426 North Avenue F, Crowley, Louisiana.

Alderman J. Elliot Doré led the Pledge of Allegiance to the flag and Alderman Jeff Doré gave the invocation.

## **PUBLIC HEARINGS:**

Mayor Greg A. Jones opened the public hearing on proposed ordinance no. 1407, the ordinance was read by title as follows:

A motion was offered by Alderman Jeff Doré and seconded by Alderman Vernon Martin to amend the city ordinance to prohibit the establishment of new trailer/mobile home parks in the city limits. Motion carried. A motion was offered by Alderman J. Elliot Doré and seconded by Alderman Jeff Doré to amend city ordinance to prohibit expansion of land area of any existing trailer/mobile home parks in the city limits. Motion carried.

A motion was offered by Alderman J. Elliot Doré and seconded by Alderwoman Kitty Valdetero to bring Appendix A-Zoning sec. 3.925(2) of the Code of Ordinance in alliance with Appendix A-Zoning sec. 2.227 of the Code of Ordinance to constitute 2 trailer/mobile homes as a trailer/mobile home park. Motion carried.

WHEREAS, the City of Crowley recently purchased and installed a new communication system with new handheld portable units and vehicle radios which are operating at a different frequency than the present system; and

WHEREAS, all the remaining Kenwood radio base units and portable radios are not compatible with the new equipment and are therefore no longer needed by the Crowley Police Department; and

WHEREAS, the remaining Kenwood radio base units and portable radios together with all accompanying equipment (microphones and chargers) should be sold by any lawful manner, including but not limited by Intergovernmental Agreement with other governmental agencies, sealed bids, auction or at the City's annual sale of surplus equipment;

NOW THEREFORE BE IT RESOLVED by the Mayor and Board of Aldermen of the City of Crowley, Acadia Parish, Louisiana, in regular session duly convened that they do hereby declare all remaining Kenwood radio base units and portable radios together with all accompanying equipment (microphones and chargers) are no longer needed for public use by the City of Crowley and are hereby declared surplus equipment and are available for sale and may be sold in any lawful means; and

BE IT FURTHER RESOLVED that they do hereby authorize the sale of the surplus equipment by Intergovernmental Agreement with other governmental agencies for a

negotiated price, by advertisement for sealed bid, by public auction or at the City's annual surplus equipment auction sale.

> A RESOLUTION URGING PRESIDENT OBAMA TO REDUCE THE FOUR MONTH MORATORIUM ON DEEP-WATER DRILLING IN THE GULF TO NO MORE THAN THIRTY (30) DAYS.

WHEREAS, in the aftermath of the British Petroleum (BP) oil spill, the Obama Administration ordered an initial six month moratorium, followed by a four month moratorium, on existing offshore drilling in the Gulf of Mexico; and

WHEREAS, the moratorium on offshore drilling will cause significant harm to Louisiana's energy service industry as well as to the many communities of Southwest Louisiana already suffering tremendously from the environmental and economic impacts of the BP oil spill; and

WHEREAS; it is estimated that each exploration and production job represents four supporting jobs in the region; and

WHEREAS; Louisiana has already experienced significant job loss since the spill and a four month moratorium will result in the further loss of thousands of jobs and millions of dollars in wages; and

WHEREAS; a moratorium will drive the Gulf of Mexico's domestic oil and gas business to other international exploration sites ultimately destroying Louisiana's most significant economic development sector; and

WHEREAS, it is unlikely that offshore drilling would resume after the moratorium is lifted given the time and investment required to relocate back to the Gulf of Mexico; and

WHEREAS, when exploration and production efforts leave the Gulf of Mexico, Louisiana will experience double digit unemployment rates and a decline in resources for investments in education, infrastructure, retraining and economic development—all needed to stabilize and grow local economies;

WHRERAS, any moratorium imposed on the oil and gas industry is detrimental to the livelihoods of the citizens of Crowley and Louisiana; and

NOW, THEREFORE, BE IT RESOLVED by the Board of Aldermen of the City of Crowley, Louisiana that:

A resolution urging President Obama to reduce the four month moratorium on offshore drilling in the Gulf of Mexico to no more than thirty (30) days.

BE IT FURTHER ORDAINED, if any provision, part, word, section, subsection, sentence, clause, or phrase of this ordinance should be held invalid by a court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this ordinance and do hereby declare the provisions hereof, to be severable, then in that event, only that particular provision, part, word, section, subsection, sentence, clause or phrase shall be deemed unconstitutional or invalid and the remaining provisions, parts, words, sections, subsections, sentences, clauses or phrases will not be affected and shall continue in full force and effect.

BE IT FURTHER ORDAINED that all ordinances or parts of ordinances inconsistent with or in conflict herewith be and the same are hereby repealed.

The following Ordinance was offered by Alderman Jeff Doré, duly seconded by Alderman J. Elliot Doré and duly ordained and adopted.

#### ORDINANCE NO. 1408

AN ORDINANCE TO AMEND AND RE-ENACT SECTION 3 OF ORDINANCE NO. 1342 AMENDING APPENDIX A OF ZONING ORDINANCE NO. 1059 OF THE CITY OF CROWLEY TO CORRECT AN ERROR IN THE DESCRIPTION OF THE BOUNDARY OF "C-3-R HIGHWAY THE DISTRICT COMMERCIAL DISTRICT - RESTRICTED" ORIGINALLY DESCRIBED IN SAID ORDINANCE TO INCLUDE WITHIN "C-3-R, HIGHWAY COMMERCIAL DISTRICT THE RESTRICTED" THE AREA BOUNDED ON THE WEST BY AVENUE F FROM 12<sup>TH</sup> STREET NORTH TO 15<sup>TH</sup> STREET; TO PROVIDE THAT THE CORRECTION SHALL BE EFFECTIVE UPON THE ORIGINAL ADOPTION OF THE ORDINANCE; TO PROVIDE THE PROVISIONS THEROF TO BE SEVERABLE; REPEAL ALL **ORDINANCES** TO OR PARTS OF ORDINANCES IN CONTRARY THERETO AND/OR IN CONFLICT THEREWITH; AND TO PROVIDE FOR ALL MATTERS RELATIVE THERETO.

WHEREAS, the Planning and Zoning Commission recommended the rezoning of the property to "C-3" subject to restrictions as set out in a letter dated June 5, 2006 describing the area to be included therein as "...bound by Avenue G and Avenue F between 10<sup>th</sup> Street and 15<sup>th</sup> Street."; and

WHEREAS, Ordinance No. 1342 was adopted on July 11, 2006 after public hearing having been held which erroneously described the area in the title and in the legal description as being bounded on the east by Avenue G, on the south by  $10^{th}$  Street and on the north by  $15^{th}$  Street when in fact the area should have been defined as being bounded on the east by Avenue G, on the south by  $15^{th}$  Street and on the west by Avenue F; and

WHEREAS, it is necessary and desirable to amend Ordinance No. 1342 to correct the District Boundary of the "C-3-R, Highway Commercial District – Restricted" in accordance with the recommendations of the Crowley Planning and Zoning Commission and as recommended in the letter of the Crowley Planning and Zoning Commission dated June 5, 2006; and

WHEREAS, it is the finding of the Board of Aldermen that the intent of Ordinance No. 1342 was to define the west boundary of the "C-3-R, Highway Commercial District – Restricted" as Avenue F; and

WHEREAS, this ordinance has been duly introduced and notice of this ordinance and notice of public hearing having been published; and

WHEREAS, a public hearing having been held in accordance with law on the 13<sup>th</sup> day of July, 2010, at 6:00 o'clock p.m. at City Hall, Crowley, Louisiana; and

NOW THEREFORE BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF CROWLEY, ACADIA PARISH, LOUISIANA IN REGULAR SESSION DULY CONVENED THAT: SECTION 1: Section 3 of Ordinance No. 1342 of the Code of Ordinances of the City of Crowley be and it is hereby corrected to substitute the following language therefor to read as follows, to-wit:

SECTION 3: The Zoning Map of the City of Crowley be and it is hereby amended to reclassify C-1 Transitional Business District to C-3-R Highway Commercial District – Restricted lying within the boundary described as follows:

Commencing at the intersection of the center line of Tenth Street with the center line of Parkerson Avenue, extending thence easterly along the center line of Tenth Street to its intersection with the center line of Avenue G; thence northerly along the center line of Avenue G to its intersection with the center line of Fifteenth Street; thence westerly along the center line of Fifteenth Street to its intersection with the center line of Avenue F; thence southerly along the center line of Avenue F to its intersection with the center line of Twelfth Street; thence easterly along the center line of Twelfth Street to its intersection with the center line of Parkerson Avenue; thence southerly along the center line of Parkerson Avenue to its intersection with the center line of Tenth Street, the point of beginning.

The said area and all property included within said boundary be and it is hereby classified "C-3-R Highway Commercial District – Restricted".

SECTION 2: The correction of the District Boundary of the "C-3-R, Highway Commercial District – Restricted" as shown herein be and it is hereby made part of the Zoning Map of the City of Crowley and the Zoning Map of the City of Crowley and said correction of the said District Boundary shall be effective as the correction of the original description stated Ordinance No. 1342 as adopted on the 11<sup>th</sup> day of July, 2010.

SECTION 3: If any provision, part, word, section, subsection, sentence, clause or phrase of this ordinance should be held invalid by a court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this ordinance and do hereby declare the provisions hereof to be severable, then in that event, only that particular provision, part, word, section, subsection, sentence, clause or phrase shall be deemed unconstitutional or invalid and the remaining provisions, parts, words, sections, subsections, sentences, clauses or phrases will not be affected and shall continue in full force and effect.

SECTION 4: All ordinances or parts of ordinances inconsistent with or in conflict herewith be and the same are hereby repealed.
