### **REGULAR COUNCIL MEETING**

### JUNE 10, 2003

The Mayor and Board of Aldermen of the City of Crowley, Louisiana, the governing authority of the City of Crowley, met in a regular session at 6:00 p.m. Tuesday the 10<sup>th</sup> day of June, 2003, at the regular meeting place of said Mayor and Board of Aldermen, the City Hall, 426 North Avenue F, Crowley, Louisiana.

Mayor de la Houssaye presided with the following Aldermen present: James M. Buatt, Vernon Martin, Mary T. Melancon, Laurita D. Pete, Steven C. Premeaux, and Kitty Valdetero. Aldermen Tiger Istre, Woody Marceaux and Ira Thomas were absent.

Alderman Premeaux led the Pledge of Allegiance to the flag and Alderman Martin gave the invocation.

Alderwoman Melancon moved to approve all bills presented for payment. Seconded by Alderwoman Valdetero and duly adopted.

### MAYOR'S REPORT:

Mayor de la Houssaye presented the Sales Tax Report and User Fee Report that compare current collections to collections from previous years. The Recap of all Funds Report compares actual revenues and expenditures for the nine months of the fiscal year to the budgeted revenues and expenditures of the same period.

### STANDING COMMITTEE REPORTS:

#### PUBLIC WORKS:

Alderwoman Melancon offered a motion to change the date of the July Council Committee meeting to June 30<sup>th</sup> and July 1<sup>st</sup> due to the JulyFete celebration. Seconded by Alderman Martin and duly adopted.

Alderwoman Melancon offered a motion to change the date of the August Council Committee meeting to August 5<sup>th</sup> and 6<sup>th</sup> due to the LMA Convention. Seconded by Alderwoman Valdetero and duly adopted.

Alderwoman Melancon offered a motion to accept the bid of \$22,000 from CLECO for the purchase of a bucket truck. Seconded by Alderman Buatt and duly adopted.

Alderwoman Melancon offered a motion to approve Partial Payment No. 2 to Emulsified Asphalt Products for Patching, Levelling, etc. under their 2002-03 Annual Materials and Street Repair Contract in the amount of \$41,813.46. Seconded by Alderman Martin and duly adopted.

Alderwoman Melancon offered a motion to approve Partial Payment No. 1 to Quality Construction Specialists for Crack Routing, Cleaning and Sealing under their 2002-03 Annual Materials and Street Repair Contract in the amount of \$11,610.76. Seconded by Alderman Martin and duly adopted.

Alderwoman Melancon offered a motion to authorize Mader Engineering to prepare Plans and Specifications for the 2003-04 Annual Materials and Street Repair Work. Seconded by Alderman Martin and duly adopted.

Alderwoman Melancon offered a motion to table Partial Payment to Morvant Construction for "Drainage Problem in the Alley between Avenue G and Avenue H from Jeanette Street to Spruce Street (Rose Menou)" to be presented by Mader Engineering at the Council meeting on June 10<sup>th</sup>. Seconded by Alderman Martin and duly adopted.

Alderwoman Melancon offered a motion to approve Partial Payment No. 1 to E. B. Feucht for the "Northview Lane, Eastern Avenue (7<sup>th</sup> to 8<sup>th</sup> Streets), Third Street (Avenue G to Avenue H—Frosto), and Third Street (Avenue K to Avenue L)" project in the amount of \$54,515.02. Seconded by Alderwoman Valdetero and duly adopted.

Alderwoman Melancon offered a motion to authorize Mader Engineering to investigate the drainage problem along the southside of 2<sup>nd</sup> Street from Avenue I to Avenue K. Seconded by Alderman Martin and duly adopted.

Alderwoman Melancon offered a motion to authorize the Mayor to engage Wastewater Services, Inc. to clean and televise the existing subsurface drainage system on Avenue G from Third Street to Fifth Street; on Avenue F from First Street to Third Street; and on Second Street from Avenue G to Parkerson Avenue. Seconded by Alderman Buatt and duly adopted.

Alderwoman Melancon offered a motion to authorize the Mayor to execute an engineering contract amendment for the Downtown Sidewalk, Street, and Safety Improvements engineering contract with Mader Engineering, Inc. to provide compensation for basic engineering services including landscape design on the basis of a fee curve. Seconded by Alderwoman Pete and duly adopted.

# UTILITY:

Alderman Martin moved to approve Partial Payment No. 12 to B & K Construction Company for the "North Crowley Pump Station and Collection Line Upgrade" in the amount of \$74,453.77. Seconded by Alderwoman Valdetero and duly adopted.

Alderman Martin moved to approve Change Order No. 4 to the B & K Construction Contract for "North Crowley Pump Station and Collection System Upgrades" to grant the Contractor a time extension of 4 days; and to authorize the Contractor to cut the structure down to 3 feet below ground and then fill up the structure with soil or sand at the abandon west side pump station on Marcel Thomas near 7<sup>th</sup> street and the abandon Westwood pump station on Marcel Thomas at the Housing Authority entrance at the cost of \$2,000 per location. Seconded by Alderwoman Melancon and duly adopted.

Alderman Martin moved to authorize the Mayor to adjust the sewer user fees for Whiteway Laundry based on 70% of the water consumed equals the volume of sewage in accordance with the Mader Engineering study conducted, with an effective date of adjustment as March 10, 2003. Seconded by Alderwoman Pete and duly adopted.

Alderman Martin moved to authorize the Mayor to continue adjusting the sewer user fees for Crowley Laundry based on 80% of the water consumed equals the volume of sewage in accordance with the Mader Engineering study conducted with an effective date of adjustment as March 10, 2003. Seconded by Alderman Buatt and duly adopted.

Alderman Martin moved to authorize the Mayor to adjust the sewer user fees for Park Avenue Cleaners based on 60% of the water consumed equals the volume of sewage in accordance with the Mader Engineering study conducted with an effective date of adjustment as March 10, 2003. Seconded by Alderwoman Pete and duly adopted.

Alderman Martin moved to table the evaluation of the ratio of wastewater to water consumption for washeteria operations. Seconded by Alderwoman Melancon and duly adopted.

Alderman Martin moved to approve Partial Payment No. 3 to Stelly Construction for the "West Crowley Sewerage Improvements (LCDBG FY 2001 Program)" in the amount of \$27,256.45. Seconded by Alderwoman Pete and duly adopted.

Alderman Martin moved to table Partial Payment No. 1 to H & S Construction for the "Wastewater Treatment Facility Driveway and Parking Lot Repairs in the estimated amount of \$40,700; approve Change Order #1 to adjust original contract quantities to final quantities and adopt a Resolution of Termination. Seconded by Alderwoman Valdetero and duly adopted.

Alderman Martin moved to authorize the Mayor and the City Attorney to proceed with the abandonment of the City's portion of the bridge and the right of way leading to the bridge at Kathy Apartments. Seconded by Alderwoman Melancon and duly adopted.

Alderwoman Valdetero moved to approve payment for the plans and specifications of the new I-10 Lighting System as prepared by Poche' – Proet Associates. Seconded by Alderman Martin and duly adopted.

## PUBLIC SAFETY:

Alderman Buatt offered a motion to promote Scott Hoffpauir from Fire Driver to Captain effective June 12, 2003. Seconded by Alderman Martin and duly adopted.

Alderman Buatt offered a motion to promote Louis Romero from Firefighter to Fire Driver effective June 12, 2003. Seconded by Alderwoman Melancon and duly adopted.

Alderman Buatt offered a motion to hire Reginald Richard to the position of Firefighter effective June 17, 2003. Seconded by Alderwoman Melancon and duly adopted.

Alderman Martin offered a motion to hire Yolanda Lewis to the position of Patrolman effective June 16, 2003, pending the passage of her physical and drug test. Seconded by Alderman Premeaux and duly adopted.

Alderwoman Valdetero offered a motion to hire Scott Fogleman to the position of Patrolman effective July 16, 2003, pending the passage of his physical and drug test. Seconded by Alderwoman Melancon and duly adopted.

## ORDINANCE NO. 1267

AN ORDINANCE TO AMEND AND RE-ENACT PARTS OF ARTICLE III OF CHAPTER 14 OF THE CODE OF ORDINANCES OF THE CITY OF CROWLEY TO AMEND SECTION 14-44, TO PROVIDE FOR ADDITIONAL REGULATIONS FOR NO PARKING BY ADDING THERETO SUB-SECTION (S) THE EAST SIDE OF AVENUE D BETWEEN MILL STREET AND ELM STREET; AND TO PROVIDE FOR ALL MATTERS IN CONNECTION THEREWITH; AND TO REPEAL ALL ORDINANCES CONTRARY THERETO.

# NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF CROWLEY, ACADIA PARISH, IN REGULAR SESSION, DULY CONVENED THAT:

SECTION 1: Section 14-44 of Article III of Chapter 14 of the Code of Ordinances of the City of Crowley be and the same is hereby amended and re-enacted to add thereto subsection (s) as follows:

Section 14-44 Regulation at specific locations.

(s) No person shall park any vehicle on the east side of Avenue D, south of its intersection with Mill Street and the intersection of Elm Street;

SECTION 2: All ordinances or parts of ordinances or resolutions or parts of resolutions inconsistent with or in conflict with the provisions of this ordinance be and the same are hereby repealed.

SECTION 3: Should any part, word, section or article of this ordinance be invalidated by any Court of competent jurisdiction, the remaining provisions, words or sections shall not be affected and shall continue in full force and effect.
