#### REGULAR COUNCIL MEETING

#### AUGUST 12, 2003

The Mayor and Board of Aldermen of the City of Crowley, Louisiana, the governing authority of the City of Crowley, met in a regular session at 6:00 p.m. Tuesday the 12<sup>th</sup> day of August, 2003, at the regular meeting place of said Mayor and Board of Aldermen, the City Hall, 426 North Avenue F, Crowley, Louisiana.

Mr. Jason Broussard led the Pledge of Allegiance to the flag and Alderman Martin gave the invocation.

WHEREAS, it is necessary to fix the compensation of the Mayor, Aldermen, Clerk, Chief of Police and all other municipal officers of the City of Crowley; and

WHEREAS, it is the finding of the Board of Aldermen that it is appropriate to establish the following salaries;

NOW THEREFORE, BE IT ORDAINED by the Board of Aldermen of the City of Crowley, Acadia Parish, in regular session, duly convened that;

# SECTION 2-4 OF CHAPTER 2 OF THE CODE OF ORDINANCES OF THE CITY OF CROWLEY BE AND THE SAME IS HEREBY AMENDED AND REENACTED TO READ AS FOLLOWS:

# Section 1:

Sec. 2-4. Same-Mayor to be full time; compensation of Mayor and other officers and officials.

- a) The office of mayor of the city is hereby established as full time office; to the performance of the duties of such office, said official shall contribute not less than forty (40) hours per week.
- b) The following salaries are hereby fixed and established for each office as set forth hereunder, to-wit:

c) The governing body shall establish and provide an expense fund for the said officials commensurate with the duties of their respective office.

If any provision, part, word, section, subsection, sentence, clause, or phrase of this ordinance should be held invalid by a court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this ordinance and do hereby declare the provisions hereof, to be severable, then in that event, only that particular provision, part, word, section, subsection, sentence, clause or phrase shall be deemed unconstitutional or invalid and the remaining provisions, parts, words, sections, subsections, sentences, clauses or phrases will not be affected and shall continue in full force and effect.

BE IT FURTHER ORDAINED that all ordinances or parts of ordinances inconsistent with or in conflict herewith be and the same are hereby repealed.

#### ORDINANCE NO. 1271

AN ORDINANCE TO AMEND AND RE-ENACT SECTION 9-30 OF ARTICLE II OF CHAPTER 9 OF THE CODE OF ORDINANCES OF THE CITY OF CROWLEY TO PROVIDE FOR THE CITY INSPECTOR TO ISSUE NOTICE OF JUNK VEHICLES AND ORDERS TO REMOVE SAME AND TO PROVIDE FOR ALL MATTERS IN CONNECTION THEREWITH; AND TO REPEAL ALL ORDINANCES OR PARTS OF ORDINANCES CONTRARY THERETO:

WHEREAS, this ordinance has been duly introduced and notice of this ordinance and notice of public hearing having been published; and

WHEREAS, a public hearing having been held in accordance with law on the 12<sup>th</sup> day of August 2003 at 6:00 o'clock p.m. at City Hall: and

WHEREAS, the Mayor and Board of Aldermen find it is necessary to amend the Ordinance to provide for the City Inspector to determine whether vehicles have been abandoned or junked and to issue notice for removal of the vehicle; and

WHEREAS, the Mayor and Board of Aldermen desire to adopt the ordinance as amended:

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF CROWLEY, ACADIA PARISH, IN REGULAR SESSION, DULY CONVENED THAT:

SECTION 1: section 9-30 of Article II of Chapter 9 of the Code of Ordinances of the City of Crowley be and the same is herby amended and re-enacted as follows:

Section 9-30 Junk-Storage; Abandoning: -Notice.

- A. As to motor vehicles. Upon determination that such motor vehicles is a junk, wrecked or used motor vehicle as hereto defined, the City Inspector shall give notice that said motor vehicle has been determined to be a junk motor vehicle and that, unless such motor vehicle is removed within ten (10) days, after notice, same shall be deemed abandoned to the city, as public property, and that such motor vehicle shall be removed and disposed of by the city. Such notice shall by placing same on the vehicle or by serving same on the owner thereof, if known, by certified mail, return receipt requested, and the city official or employee giving such notice shall make proper return, giving the date on which and the manner in which such notice was served.
- B. As to other junk. In the case of other junk, discarded or abandoned property referred to in section 9-28, and situated on any private property, notice that such material has been determined to be junk, discarded or abandoned property and that same will be removed and disposed of at the cost and expense of the owner of such parcel of ground ten (10) days after service of such notice, shall be served to the owner of the parcel of ground on which such junk material is situated by certified mail, return receipt requested, by the City Inspector.

SECTION 2: All ordinances or parts of ordinances or resolutions or parts of resolutions inconsistent with or in conflict with the provisions of this ordinance be and the same are hereby repealed.

SECTION 3: Should any part, word, section or article of this ordinance be invalidated by any Court of competent jurisdiction, the remaining provision, words or sections shall not be affected and shall continue in full force and effect.
