### REGULAR COUNCIL MEETING

### **MARCH 11, 2003**

The Mayor and Board of Aldermen of the City of Crowley, Louisiana, the governing authority of the City of Crowley, met in a regular session at 6:00 p.m. Tuesday the 11<sup>th</sup> day of March, 2003, at the regular meeting place of said Mayor and Board of Aldermen, the City Hall, 426 North Avenue F, Crowley, Louisiana.

Mayor Pro-Tem James M. Buatt presided with the following Aldermen present: Tiger Istre, Woody Marceaux, Laurita D. Pete, Steven C. Premeaux, and Kitty Valdetero. Aldermen Vernon Martin, Mary T. Melancon, and Ira Thomas were absent.

The Pledge of Allegiance to the flag was recited and Alderman Buatt gave the invocation.

# **READING & APPROVAL OF MINUTES / BILLS:**

Alderwoman Pete moved to amend the minutes of February 11, 2003 by deleting the following paragraph in the resolution for the transfer of computer modems:

"WHEREAS, the Sheriff of Acadia Parish maintains a computerized link or access to the Louisiana State Police Criminal Information Database which provides Law Enforcement officers with real time information directly in their police units; and "

"WHEREAS, the Sheriff of Acadia Parish maintains a computerized link by access to the Louisiana State Police Criminal Information Database and the National Crime Information Center, which provides Law Enforcement officers with real time information directly to their police units; and "

WHEREAS, the City of Crowley Wastewater Treatment Department operates an automated data collection system (SCADA) for remote monitoring of the wastewater collection system; and

WHEREAS, the SCADA system has not operated efficiently due to corrosion and moisture causing failure of electronic equipment and components; and

WHEREAS, the City engaged Automated Solutions, Inc. to perform an evaluation of the SCADA system to identify the scope of work and to make recommendations to restore the system; and

WHEREAS, the City Engineer has recommended that system should be refurbished, with the replacement of certain electronic components, corrosion resistant wiring and connections and improved moisture seals; and has further recommended upgrading the system of hardware and software to current technologies; and

WHEREAS, Automated Solutions, Inc. has provided a proposal for refurbishing the system, upgrading the hardware and software and a proposal for an annual maintenance contract;

NOW THEREFORE, BE IT RESOLVED by the Mayor and Board of Aldermen of the City of Crowley, Acadia Parish, Louisiana, in regular session duly convened they do hereby authorize, empower and direct the Honorable Isabella L. de la Houssaye, Mayor to negotiate and execute a contract with Automated Solutions, Inc. for the refurbishing of the SCADA System, including the installation of certain electronic components, corrosion resistant wiring and connections, improved moisture seals and the upgrading of hardware and software, for an initial cost of \$57,300; and

BE IT FURTHER RESOLVED that the Honorable Isabella L. de la Houssaye, Mayor be and she is hereby authorized, empowered and directed to negotiate and execute a contract for annual maintenance of the SCADA system at initial cost of \$7,600.

BE IT FURTHER RESOLVED that the said Isabella L. de la Houssaye, Mayor be and she is hereby authorized, empowered and directed to execute all necessary documents that may be necessary to conclude the matter.

COLLECTION SYSTEM

WHEREAS, personnel from the Wastewater Treatment Department are required to manually monitor certain overflow points of the Wastewater Collection System during heavy rainfall events; and

WHEREAS, the City Engineer has recommended the installation of flow monitors at the Main Pump Station, Ash Street, Avenue M and the Wet Weather Basin transfer pipe; and

WHEREAS, these flow monitors will automatically collect data and store information during periods of heavy rainfall events without the necessity of manually monitoring the locations and will be capable of integration with the SCADA system;

NOW THEREFORE, BE IT RESOLVED by the Mayor and Board of Aldermen of the City of Crowley, Acadia Parish, Louisiana, in regular session duly convened they do hereby authorize, empower and direct the Honorable Isabella L. de la Houssaye, Mayor to negotiate and execute a Contract with the Spectrum Group to furnish and install four flow monitors at the following locations, Main Pump Station; Ash Street; Avenue M and the Wet Weather Basin transfer pipe, for a total estimated cost of \$25,000.00

Alderwoman Valdetero moved to authorize the Mayor to engage the services of Tim Morton to inspect and issue a wetlands determination and recommendation for the new sewer line to be installed along the east property line of the B. W. Freeland Estate for the North of I-10 Sewerage Extension Project for an amount not to exceed \$4,000. Seconded by Alderwoman Pete and duly adopted.

Alderwoman Valdetero moved to authorize Partial Payment No. 2 for the release of retainage in the amount of \$1,678.55 (includes \$500 for Punch List retainage) to Wastewater Services, Inc. under their contract with the City of Crowley for Sewer Extension on Capital Avenue for the Detention Center. Seconded by Alderman Istre and duly adopted.

RESOLUTION OF THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF CROWLEY, ACADIA PARISH, LOUISIANA, TO AUTHORIZE AN INTERGOVERNMENTAL AGREEMENT WITH THE LOUISIANA DEPARTMENT OF TRANSPORTATION AND DEVELOPMENT TO PAY (10%) PERCENT OF THE COST OF CONSTRUCTION AND ASSUME LEGAL LIABILITY FOR ALL MAINTENANCE AND OPERATION COST OF A NEW HIGHWAY LIGHTING SYSTEM FOR THE LA 13 AND I-10 HIGHWAY INTERCHANGE.

WHEREAS, the Acadia Parish Police Jury maintains and operates a highway lighting system for the LA 13 and I-10 Highway interchange under an Intergovernmental Agreement with the Louisiana Department of Transportation and Development (LDOTD); and

WHEREAS, the LDOTD and the City of Crowley have agreed that the present lighting system is near the end of its useful life and the cost of repairs is excessive given the age of the system; and

WHEREAS, the LDOTD will construct a new highway lighting system for the LA 13 and I-10 interchange; and

WHEREAS, the LDOTD has requested that the Board of Aldermen authorize an Intergovernmental Agreement which obligates the City of Crowley to pay ten (10%) percent of the construction cost, and assume all legal liability for, and all of the maintenance and operating cost of the new lighting system;

NOW THEREFORE, BE IT RESOLVED by the Mayor and Board of Aldermen of the City of Crowley, Acadia Parish, Louisiana, in regular session duly convened that they do hereby authorize, empower and direct the Honorable Isabella L. de la Houssaye, Mayor of the City of Crowley to execute an Intergovernmental Agreement with the Louisiana Department of Transportation and Development (LDOTD) to obligate the City of Crowley to pay ten (10%) percent of the construction cost, and assume all legal liability for, and responsibility for all maintenance and the operating cost of the lighting system at the LA 13 and I-10 highway interchange, State Project Number 450-04-027, Federal Aid Project No. I-10-20 (300) 80, Roadway Lighting Route LA 13 Interchange (Crowley) Route I-10, Acadia Parish upon the acceptance of the project by the LDOTD.

BE IT FURTHER RESOLVED that if any portion or part of this resolution or the application thereof is held invalid, such invalidity should not affect other provisions, parts or application of this resolution which can be given affect without the invalid provisions, items, or applications and to this in the provisions of this resolutions hereby declared separable.

BE IT FURTHER RESOLVED all resolutions and parts thereof in conflict here would be replaced.

- 2. In the event the display case is no longer useful to the City it shall revert to Noelle Freeland, until her death and be transferred at no cost to Noelle Freeland or to any public museum in Crowley, Jennings or Lafayette, Louisiana and if none accept, to any public school in Crowley, Jennings or Lafayette, Louisiana; and if not accepted by the above museums or schools or after the death of Noelle Freeland, that it be auctioned to the highest bidder and the balance after expenses shall be used for improvements to the Freeland Park; and

WHEREAS, the Mayor and Board of Aldermen of the City of Crowley desire to accept the said donation with their gratitude and thanks to Thomas B. and Mary Tryon Freeland;

NOW THEREFORE, BE IT RESOLVED by the Mayor and Board of Aldermen of the City of Crowley, Acadia Parish, Louisiana, in regular session duly convened that they do hereby accept the donation of one (1) large Victorian style oak glass display case originally belonging to W.T. WHEREAS, Hurricane Lili caused the loss of electrical power in the City of Crowley for approximately five days; and

WHEREAS, in order to maintain sewer service during the electrical outage, it was necessary to transport wastewater from pump stations by large 18-wheel vacuum tank trucks to the Wastewater Treatment facility; and

WHEREAS, the Wastewater Treatment facility driveway and parking lot were heavily damaged by heavy truck traffic; and

WHEREAS, the City is eligible to receive reimbursement of 75% of the cost of repairs from FEMA for hurricane related damages; and

WHEREAS, the City Engineer has reported that the electronic control panels have severely deteriorated over the past ten (10) years due to corrosion; and

WHEREAS, the City Engineer and the Wastewater Treatment Superintendent recommend that repairs to the building and facility should be made immediately to avoid pump down time and to reduce the need to open access hatches in the facility to minimize excess moisture; and

WHEREAS, the estimated cost of repairs and renovations to the building is approximately \$8,000 to \$10,000 and replacement of the control panel is approximately \$28,000;

NOW THEREFORE, BE IT RESOLVED by the Mayor and Board of Aldermen of the City of Crowley, Acadia Parish, Louisiana, in regular session duly convened they do hereby authorize, empower and direct the Honorable Isabella L. de la Houssaye, Mayor to negotiate and execute a Contract for the repair and renovations of the Main Pump Station building and the replacement of the control panel, as necessary to bring the facility up to acceptable standards; and
