Alderwoman Melancon moved to amend the agenda to include a trailer petition for property at 4<sup>th</sup> and Spann belonging to Quatrina Comeaux. Seconded by Alderman Martin and duly adopted after a unanimous vote.

Alderman Istre moved to amend the agenda to consider moving a building for the Fire Department. Seconded by Alderman Thomas and duly adopted after a unanimous vote.

Alderman Buatt moved to amend the agenda to consider a gate for the Fire Training ground. Seconded by Alderman Thomas and duly adopted after a unanimous vote.

Alderman Buatt offered a motion to ratify Mayor de la Houssaye's recommendation and promote Albert John to the position of Director of Public Works, effective March 30, 2004. Seconded by Alderwoman Melancon and duly adopted.

Alderwoman Melancon moved to approve a trailer petition from Quatrina L. Comeaux to park a trailer on the property located at the corner of West 4<sup>th</sup> and Spann with a legal description of Lot 7 Block 3 Walker Addition. Seconded by Alderman Martin and duly adopted.

Alderman Martin moved to accept the recommendation of Chief Schmaltz and allow Spell House Moving to move a building to the Fire Training ground at a cost not to exceed \$2,000. Seconded by Alderwoman Melancon and duly adopted.

Alderman Martin moved to accept the recommendation of Chief Schmaltz to purchase a 40-foot rolling gate from Dailey's Fence Co. to be installed at the Fire Training ground at a cost of \$2,225 and amend the fence contract to include the gate. Seconded by Alderman Thomas and duly adopted.

There being no further business to come before the Council upon motion duly made by Alderwoman Melancon and seconded by Alderman Buatt the meeting was adjourned at 6:00 p.m.
