## CITY OF CROWLEY REGULAR MEETING NOVEMBER 13<sup>TH</sup>, 2019

The Mayor and Board of Aldermen of the City of Crowley, Louisiana, the governing authority of the City of Crowley, met in a regular session at 6:00 p.m. Wednesday the 11<sup>th</sup> day of November 2019 at the regular meeting place of said Mayor and Board of Aldermen, the Council Chambers, 426 North Avenue F, Crowley, Louisiana.

Mayor Tim Monceaux presided with the following Aldermen present: Jeff Cavell, Thompson Bradford Core, Clint Cradeur, Lyle Fogleman, Jr., Samuel J. Reggie, III, Kim Stringfellow, Byron K. Wilridge, and Steven Premeaux. Alderman Vernon Martin was absent at roll call, but joined the meeting shortly there after.

Alderman Brad Core led the Pledge of Allegiance to the flag. Alderman Clint Cradeur gave the invocation.

#### **READING & APPROVAL OF MINUTES:**

Alderman Lyle Fogleman moved to dispense with the reading of the minutes of the October 8<sup>th</sup>, 2019 regular council meeting and approve them as written and distributed. Seconded by Alderman Jeff Cavell and duly adopted.

Alderman Brad Core moved and seconded by Alderman Byron Wilridge to dispense with the reading of the minutes of the October 25<sup>th</sup>, 2019 special council meeting and approve them as written and distributed.

#### **MAYOR'S REPORTS:**

Mayor presented the Sales Tax chart and User Fee chart that track the collection trend.

Mayor presented the monthly budget-to-actual comparisons that report the spending of major funds.

#### **APPEARANCES:**

Mr. Kurt Guidry, Regional Director with the LSU Ag Center to address the council stating what services the AG Center offers and to ask for support of the millage renewal that funds the Ag Center and the Rice Arena.

Mrs. Sonjatina Wilridge address the council regarding a statement she prepared regarding the Crowley Police Department and the disrespectful treatment of the police department at the Crowley Head Start school. Chief Broussard spoke in turn and stating that he is investigating the matter and it will be handled.

A motion was offered by Alderman Clint Cradeur and seconded by Alderman Vernon Martin to forward the cemetery maintenance discussion to the full Council at the November 13<sup>th</sup> City Council meeting. Motion carried.

Alderman Clint Cradeur stated that he and the Mayor are working on obtaining three quotes and once those quotes are received the final decision will be made at the next regular council meeting.

A motion was offered by Alderman Clint Cradeur and seconded by Alderman Vernon Martin to recommend authorizing the construction of drainage improvements on 16th Street between Avenue D and Avenue E, as called for under the City-Wide Drainage Improvements project, to be accomplished as soon as possible under the City's existing Contract for Labor and Equipment General Construction Work with Southern Constructors, LLC, and authorize Mader Engineering to do resident inspections, as required. Motion carried.

A motion was offered by Alderman Vernon Martin and seconded by Alderwoman Kim Stringfellow to forward the discussion of the H & H Electric Contract to the full Council, at the November 13<sup>th</sup> meeting, for a decision on handling the contract going forward. Motion carried.

A question was posed to legal counsel by Alderman Jeff Cavell regarding the answer to this issue and Mr. Woodrow stated that the purchase order is an integral part of the contract and the contractor should be allowed to complete the job specified by that particular purchase order.

Motion carried.

A motion was offered by Alderman Brad Core and seconded by Alderman Byron Wilridge to bring to the full Council for discussion the request of Police Chief Broussard to purchase a new recorder for phone and radio for the Crowley Police Department. Motion carried. Alderwoman Stringfellow opposed.

A motion to table the request of Police Chief Broussard to purchase a new recorder for phone and radio for the Crowley Police Department was made by Alderman Brad Core and seconded by Alderman Kim Stringfellow.

Alderman Vernon Martin offered and seconded by Alderman Byron Wilridge a substitute motion to honor the request of Police Chief Broussard to reiterate that the chief has authority to purchase a new recorder for phone and radio as the Lawrson Act allows. Motion carried.

A motion was offered by Alderman Brad Core to bring to the full Council for discussion the request of Police Chief Broussard to purchase new Kenwood radios (portable and base car units) for the Crowley Police Department, utilizing a "buyback" program from LRC Wireless to assist in the purchase. Alderman Brad Core offered a motion to table this motion until further clarification can be determined. Seconded by Alderwoman Kim Stringfellow. Motion Carried.

A motion was offered by Alderman Brad Core and seconded by Alderwoman Kim Stringfellow to amend the Committee Agenda to add as a discussion item, and forward to the full council for discussion, the renovation and repair to the central fire station. Motion carried.

Discussion ensued regarding the renovation of the fire department building and the next steps that are to be taken in regard to the building.

A motion was offered by Alderman Brad Core to direct the Mayor to form an advisory committee to come to a decision on what needs to be done on the renovation with a committee member being an architect that is familiar with firehouse construction be included. Seconded by Alderman Clint Cradeur. Motion carried.

A motion was offered by Alderman Byron Wilridge and seconded by Alderman Clint Cradeur to amend the agenda to include as a discussion item, and to be heard before the full Council at the November 13<sup>th</sup> City Council meeting, the City co-sponsoring with Jerusalem Baptist Church for the use of the Martin Luther King building for a Thanksgiving meal to be held at the MLK Center, tentatively on Sunday, November 24<sup>th</sup>. Motion carried.

A motion was offered by Alderman Byron Wilridge and seconded by Alderman Clint Cradeur to amend the agenda to include as a discussion item, and to be heard before the full Council at the November 13<sup>th</sup> City Council meeting, an update on the Rice Museum. Motion carried.

Mayor Tim Monceaux stated that he had spoken to Mrs. Charlotte Jeffers and she stated that she is currently working on this list and hopes to have it for the December council meeting.

A motion was offered by Alderman Byron Wilridge and seconded by Alderman Brad Core to bring before the full council at the November 13<sup>th</sup> City Council meeting the discussion of the old Cajun Bag Building. Motion carried.

Discussion was held regarding the sale of the Island Plantation building. Mayor stated that someone was interested in purchasing the building and legal counsel advised that an appraisal be completed. The Mayor said once he received the appraisal, he notified the interested party and never received a response.

An ordinance was introduced by Alderman Byron Wilridge to introduce an ordinance to allow City of Crowley to advertise for bids to sale the Island Plantation building owned by the City of Crowley.
