CITY OF CROWLEY REGULAR MEETING JANUARY 8TH, 2020

The Mayor and Board of Aldermen of the City of Crowley, Louisiana, the governing authority of the City of Crowley, met in a regular session at 6:00 p.m. Wednesday the 8^h day of January 2020 at the regular meeting place of said Mayor and Board of Aldermen, the Council Chambers, 426 North Avenue F, Crowley, Louisiana.

Mayor Tim Monceaux presided with the following Aldermen present: Jeff Cavell, Thompson Bradford Core, Clint Cradeur, Lyle Fogleman, Jr., Steven Premeaux, Samuel J. Reggie, III, Kim Stringfellow, Byron K. Wilridge and Vernon Martin.

Alderman Sammy Reggie led the Pledge of Allegiance to the flag. Alderman Lyle Fogleman gave the invocation.

PUBLIC HEARINGS:

A motion to table the public hearing on Ordinance 1504 was made by Alderman Lyle Fogleman and seconded by Steven Premeaux due to the inability of a meeting to be held with the City Attorney. Motion carried.

A motion was made by Alderman Lyle Fogleman and seconded by Alderman Jeff Cavell to reset the rule to show cause on property belonging to Michael Stafford and Casey Comeaux Stafford situated on Lots 2 and 3 of Block 2 of the Savy Broussard Subdivision bearing municipal address of 1008 West 11th Street. Crowley, LA and property belonging to Vanessa Clement situated on Lots 13-14 of Block 19 of Duson's 3rd Addition to the City of Crowley bearing a municipal address of 1116 West 5th Street at the request of Mr. Glenn Howie to be held on February 12th, 2020. Motion carried.

APPEARANCES:

Mr. Dave Bratton addressed the council regarding his sewer extension project and wanted the council to know that he was not pleased with the way the City handled the extension nor was the City responsible for the completion of the sewer extension.

Mr. Tim Roy addressed the council regarding Lyle Fogleman a safety issue with property located at 416 North Avenue E that is set to be condemned.

Mr. Robert L. Trahan addressed the council regarding the sale of Lots 6 and 7 of Block 34 of the South Crowley Addition, he stated that he is interested in purchasing the property due to his business, Falcon Rice Mill, being landlocked and the need to expand.

READING & APPROVAL OF MINUTES:

Alderman Jeff Cavell moved to dispense with the reading of the minutes of the December 6th, 2019 special council meeting, December 10th, 2019 special council meeting and the December 11th, 2019 regular council meeting and approve them as written and distributed. Seconded by Alderman Vernon Martin and duly adopted.

MAYOR'S REPORTS:

Mayor presented the Sales Tax chart and User Fee chart that track the collection trend.

Mayor presented the monthly budget-to-actual comparisons that report the spending of major funds.

A motion was offered by Alderman Clint Cradeur and seconded by Alderman Lyle Fogleman to authorize the procurement of a construction contract for the repair of deteriorated bridge piles for Pine Street Bridge, Avenue D Bridge, Jacobs Avenue Bridge, and Cedar Street Bridge. Motion carried.

UTILITY COMMITTEE:

Chairperson – Alderman Vernon Martin Vice-Chairperson – Alderman Sammy Reggie Members – Aldermen Jeff Cavell, Lyle Fogleman, Jr., and Clint Cradeur

A motion was offered by Alderman Vernon Martin and seconded by Alderman Jeff Cavell to instruct the City Attorney and the Mayor to review City Ordinance 10.36, entitled "Review Sewer User Fees," and, to incorporate a panel/committee comprised of the Mayor, City Clerk, City Engineer, City Auditor, and City Attorney, for an annual review, initiated by the City Clerk, of the sewer user fees on or before May 1st of each year along with the findings to be required to brought before the board of alderman each year.

A substitute motion was offered by Alderman Jeff Cavell and seconded by Alderman Brad Core to instruct the City Attorney and the Mayor to review the City Ordinance 10.35, entitled "Review Sewer User Fees," and, to incorporate a panel/committee comprised of the Mayor, City Clerk, City Engineer, City Auditor, City Attorney, and the Chairman of the Revenue and Finance Committee for an annual review, initiated by the City Clerk, of the sewer user fees on or before May 1st of each year along with the findings be brought before the board. Motion carried.

ZONING & ANNEXATION COMMITTEE:

Chairperson – Alderman Lyle Fogleman Vice-Chairperson – Alderman Vernon Martin Members – Aldermen Sammy Reggie, Kim Stringfellow and Steven Premeaux

A motion was offered by Alderman Lyle Fogleman and seconded by Alderman Sammy Reggie to defer the action item approving the favourable recommendation of the City of Crowley Planning Commission to increase the salary of the Crowley Planning Commission secretary from \$300 to \$500 a month, as the matter is an administrative issue, to be handled by the Mayor and the City Attorney, and the council has no jurisdiction to set the salary. Motion carried.

A motion was offered by Alderman Lyle Fogleman and seconded by Alderman Steven Premeaux to recommend to the full council, based upon the favourable recommendation of the City of Crowley Planning Commission, the approval of a conditional use permit for Coffee Bean Roasting, owned by Douglas LeBlanc, located on Lots 13 - 14 of Block 160 of the City of Crowley, with the condition that there is no more than 500 lbs. of coffee beans roasted per month at this location, and further, that the location never serve as a retail outlet. A motion to rescind the motion was made by Alderman Lyle Fogleman.

A motion was offered by Alderman Brad Core and seconded by Alderman Lyle Fogleman to table the favorable recommendation of the City of Crowley Planning Commission the approval of a conditional use permit for Coffee Bean Roasting, owned by Douglas Leblanc, until next committee meeting in order for additional questions to be answered. Motion carried.

PUBLIC SAFETY COMMITTEE:

Chairperson – Alderman Brad Core. Vice-Chairperson – Alderman Byron Wilridge Members – Aldermen Vernon Martin, Kim Stringfellow and Steven Premeaux

A motion was offered by Alderman Brad Core and seconded by Alderman Vernon Martin to request the City Attorney review Chapters 54, 58, and 74 of the City of Rayne Code of Ordinances; and to request the City Attorney prepare necessary documents to transfer duties of the Animal Control Officer from Code Enforcement to the Police Department. Motion carried.

A motion was offered by Alderman Brad Core and seconded by Alderman Vernon Martin to authorize the appropriation of \$3,750.00 to provide and install electrical items for the light pole at Exit 82, as proposed by Ernest P. Breaux, dated December 26, 2019. Motion carried.

A motion was offered by Alderman Brad Core and seconded by Alderman Lyle Fogleman to approve the following renewal permits for 2020 beer and liquor licenses provided that all late fees and fines are applied:

L. Habetz Builders. Motion Carried
