RESOLUTION:

The following resolution was offered by Alderman Steven Premeaux, duly seconded by Alderman Jeff Cavell, and passed.

A RESOLUTION OF THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF CROWLEY, ACADIA PARISH, LOUISIANA, INTRODUCING A PROPOSED ORDINANCE AND CALLING FOR A PUBLIC HEARING CONCERNING SAME.

WHEREAS, an ordinance has been proposed to be adopted by the Board of Aldermen of the City of Crowley; and

WHEREAS, the proposed ordinance must be introduced by its title; and

WHEREAS, a public hearing must be held prior to its adoption; and

WHEREAS, the title of the proposed ordinance must be published in the official journal and the notice shall provide the time and place where the Board will consider its adoption;

NOW THEREFORE BE IT RESOLVED by the Mayor and Board of Aldermen of the City of Crowley, Acadia Parish, Louisiana, that the following ordinance be and it is hereby introduced for consideration and to hold a public hearing at the next regular meeting of the Mayor and Board of Aldermen, to-wit:

AN ORDINANCE TO AMEND AND RE-ENACT SECTION 3-2 OF ARTICLE I OF CHAPTER 3 OF THE CODE OF ORDINANCES OF THE CITY OF CROWLEY TO ADD SECTION (b) THERETO TO PROVIDE FOR THE AUTHORIZATION OF SPECIAL EVENT PERMITS FOR THE SALE OF ALCOHOLIC BEVERAGES IN OR ON PREMISES LOCATED WITHIN THREE HUNDRED (300) FEET OF A CHURCH, SYNAGOGUE, LIBRARY, PLAYGROUND OR SCHOOL WHEN A SPECIAL EVENT PERMIT IS ISSUED UNDER THE PROVISIONS OF SECTION 3-20.1 OF THIS CHAPTER, IN ACCORDANCE WITH ALL THE LIMITATIONS, REGULATIONS AND RESTRICTIONS THEREIN; TO PROVIDE THE ORDINANCE SHALL BECOME EFFECTIVE IMMEDIATELY UPON ADOPTION; TO REPEAL ALL ORDINANCES OR PARTS OF ORDINANCES CONTRARY THERETO OR IN CONFLICT THEREWITH; TO PROVIDE FOR THE PROVISIONS HEREOF TO BE SEVERABLE; AND TO PROVIDE FOR ALL MATTERS RELATIVE THERETO.

The Board of Aldermen of the City of Crowley shall meet in regular session on the 11<sup>th</sup> day of March, 2020, at 6:00 o'clock p.m. in the Council Chambers, 2<sup>nd</sup> Floor, Criminal Justice Building, 426 North Avenue F, Crowley, Louisiana, to hold a public hearing and to consider the adoption of the following ordinance:
