## **RESOLUTION:**

The following resolution was offered by Alderman Brad Core, duly seconded by Alderwoman Kim Stringfellow. Motion carried.

A RESOLUTION OF THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF CROWLEY, ACADIA PARISH, LOUISIANA, AUTHORIZING AN COOPERATIVE ENDEAVOR AGREEMENT WITH HASEYA'S NEW BEGINNING INC. AND KELLI BRISCOE, INDIVIDUALLY, TO ASSUME THE RESPONSIBILITY FOR THE OPERATION AND UPKEEP OF THE CITY OF CROWLEY ANIMAL CONTROL SHELTER, TO PROVIDE FOOD, MEDICINE AND VETERINARY SERVICES FOR ANIMALS AT NO COST TO THE CITY, TO PROVIDE TRAINED PERSONNEL AND SUPERVISE ADOPTIONS AND PROPER PLACEMENT OF ANIMALS, TO RESPOND TO COMPLAINTS BY CITIZENS AND ANIMAL RIGHTS ORGANIZATIONS, TO HANDLE PUBLIC RELATIONS IN REGARD TO THE CARE OF THE ANIMALS AND THE OPERATION AND UPKEEP OF THE CITY OF CROWLEY ANIMAL CONTROL SHELTER; AND TO PROVIDE FOR ALL MATTERS RELATIVE THERETO.

WHEREAS, the City of Crowley owns and operates the City of Crowley Animal Control Shelter located at 220 Jack Mitchell Avenue Road, Crowley, Louisiana; and

WHEREAS, Haseya's New Beginnings, Inc., a local non-profit organization, has offered to assume the operation, maintenance and upkeep of the City of Crowley Animal Control Shelter, including the care of the animals housed therein; and

WHEREAS, the Mayor and Board of Aldermen believe it is in the best interest of the City of Crowley and its citizens to enter into a Cooperative Endeavor Agreement with Haseya's New Beginning Inc. and Kelli Briscoe, individually, to assume the responsibility of the operation and upkeep of the facility, to provide food, medicine and veterinary services for .animals at no cost to the City of Crowley, to provide trained personnel and supervise adoption and proper placement of animals, to respond to complaints by citizens and animal rights organizations, to handle public relations in regard to the care of the animals and the operation and upkeep of the City of Crowley Animal Control Shelter; and

NOW THEREFORE BE IT RESOLVED by the Board of Aldermen of the City of Crowley, Acadia Parish, Louisiana, in regular session duly convened that they do hereby authorize, empower and direct the Honorable Tim Monceaux, Mayor of the City of Crowley, to enter into a Cooperative Endeavor Agreement with Haseya's New Beginning Inc. and Kelli Briscoe to assume the operation and upkeep of the City of Crowley Animal Control Shelter, including adequate labor and personnel to care for and feed the animals and to clean all the cages and kennels daily or as may be needed, to provide food, medicine and veterinary services for the animals at no cost to the CITY, to provide trained personnel and supervise adoption and proper placement of animals with suitable parties in compliance with CITY Ordinances and State Statutes in order to reduce and attempt to eliminate the use of euthanasia to the maximum extent possible, to respond to complaints by citizens and animal rights organizations, to handle public relations in regard to the care of the animals and the operation and upkeep of the City of Crowley Animal Control Shelter provided that the said Cooperative Agreement shall contain an indemnity and hold harmless clause in favor of the City of Crowley and shall require Haseya's New Beginning Inc. to obtain general liability insurance coverage in an amount not less than \$1,000,000.00 and to name the City of Crowley as an additional insured on any insurance policy issued to Haseya's New Beginning Inc.; and

BE IT FURTHER RESOLVED that the Cooperative Endeavor Agreement shall maintain all the usual terms and conditions as may be necessary and proper in the premises; and

BE IT FURTHER RESOLVED that the Honorable Tim Monceaux, Mayor, be and he is hereby empowered and directed to execute any and all other documents as may necessary for the implementation of the said Agreement and may be meet and proper in the premises in his sole discretion.

THUS DONE AND ADOPTED in special session duly convened on the 23<sup>rd</sup> day of June, 2020, at Crowley, Acadia Parish, Louisiana, after notice thereof having been properly posted, at which a quorum was present and acting throughout.
